



# WHY ONLINE LEARNING WILL BE HERE TO STAY POST-PANDEMIC

**Here are the keys to a sustainable online learning program**

**A** [RAND Corp. research report](#) found that 1 in 5 US school districts plan to offer fully online learning even after the pandemic ends.

Many districts are choosing to continue offering fully virtual and/or hybrid learning options post-pandemic because of the flexibility it offers families as well as the ability to meet diverse student learning needs and personalize learning. It also fulfills the critical need to have virtual learning options in the event of illnesses, school closures or emergencies.

According to a [Tuscany Strategy Consulting](#) Stride LEA Survey, districts expect to continue to serve approximately 25% of students virtually in the upcoming school year. Respondents indicate they

believe the COVID-19 pandemic will have a lasting impact on virtual learning investment and demand.

“We polled some districts recently and we found that even though people are getting vaccinations and starting to see light at the end of the tunnel, a lot of families are saying they still want virtual options. People do realize they need a virtual solution,” says Jodi Marshall, senior vice president at Stride Learning Solutions.

While districts are looking to continue virtual learning options, some had better experiences than others with online learning over the past year. Learning loss is evidence of this.

Marshall says some educators and students were thrown into emergency remote learning last year,

versus a designed virtual education experience, such as what Stride offers with its instructional design and planned scope and sequence of learning.

“It’s different than just suddenly taking what you were doing in a brick-and-mortar and putting it online overnight,” Marshall explains.

If online learning is here to stay, then what can schools do to be more proactive in its inception? How can districts “think bigger” about virtual learning?


“We’ve seen students that we may not have expected to see flourish in this environment, really flourish,” Marshall points out. “This has taught us a lot about how our kids learn, what they need based on the content level or grade level or subject area. We are learning that there is something for everyone.”

Marshall explains that diverse learners — this includes those in gifted and special education, and English as a second language students, too — all can thrive in online learning. But to really deliver effective and sustainable online learning, Marshall says a program must have three major components: a holistic foundation; technology that works and that keeps data accurate and safe; and dynamic content that works for each age group and ability.

## DYNAMIC, DEVELOPMENTALLY APPROPRIATE CURRICULUM AND CONTENT

Effective virtual or hybrid learning utilizes interactive, dynamic, engaging content; a project-based learning curriculum that provides opportunities for active, real-world learning; an adaptive personalized curriculum; and content that is developmentally appropriate to address the needs of individual learners.

Diverse learners can learn online — and some learn better that way — but adaptations and customizations must be made to adequately support each student. Instructional plans and other modifications cannot just be thrown to the side. Continuity is needed to ensure students thrive.

Marshall says that, moving forward, she expects online learning to be less of a rigid break and more of a fully incorporated option of schooling.

"I think online learning is going to evolve into an even more student-centered approach than it is now. The menu of options is going to get more and more specific, and we're going to see the lines blur," Marshall predicts.

Educators and administrators must be on board with this continued evolution for it to support students the way it should, however.

"If you don't actually believe that blended, hybrid and online is essential to diversifying the learning options, you're failing right out of the gate," Pignatiello says.

She adds that diverse learners require choices in learning delivery methods and the actual content. Even individual students may require diversity of learning options within their educational plan.

"Online learning, both blended and hybrid options, provides an opportunity for the students and the whole family to find options that work for them," Pignatiello says.

## PROACTIVE TEACHER DEVELOPMENT

Before the pandemic, the vast majority of educators and classroom teachers were not experienced in virtual instruction. Research shows that professional development has proven beneficial to teachers improving their effectiveness and comfort level in virtual instruction. Teachers need to feel supported with resources and professional learning opportunities so they can also thrive in a virtual or hybrid setting.

The shift to online or blended learning can be smoothed out through comprehensive teacher training programs. 

space for parents where there has never been that type of feedback or interaction, but it is important to student success, she notes.

The role of the parent, the role of the teacher and the role of the student will evolve because technology always evolves. I think it is critical that any virtual learning program has elements of listening and the ability to change. As tools and technology continue to improve, we need to be able to adjust,” Marshall says.
